Let's Make the Purple Line a Reality By Tony Hausner

For over 20 years, environmental, civic, business, and activist groups have been fighting to add a Purple Line to the region's Metrorail system. For this to become a reality, we must act now. This light rail project would run from Bethesda to New Carrollton, with stops in Chevy Chase, College Park, Silver Spring, Takoma/Langley, and more. More importantly, in the midst of growing concern about our climate, unceasing traffic congestion, long commutes, and a looming recession impacted by high gas prices, the Purple Line would encourage environmentally responsible development, take 20,000 cars off the road, shorten commutes and improve our economy. The Purple Line provides a better alternative to transportation than accommodating more cars, such as by widening the Capital Beltway. There are several actions you can take to make this Light Rail Transit Line a reality. 1. Participate in the public hearings.

PRESIDENT'S COLUMN

SEVERAL OF MY RECENT COLUMNS HAVE BEEN DOMINATED BY ONE SUBJECT—CRIME. I'd like to be able to change the subject, but ongoing concern about crime in our neighborhood compels me to keep focused on it. On October 20, 7:30 pm, we will have an ISCA general meeting about crime at the Rec Center. We'll be joined by two top-ranking officers from the Montgomery County Police, Silver Spring district. We're also inviting our representatives from the County Council—though their attendance is not guaranteed at this moment.

Although it will be our second general meeting on crime in less than a year, I think the recent rash of car break-ins, attempted home break-ins, and this summer's disturbing shooting make the meeting imperative. Your ISCA board has been putting pressure on the police to step up patrols and accelerate the investigation into the shooting, which as far as we know, has not yet been solved. More than ever, it is critically important that you show up to this meeting and make your voices heard. We need the police to understand how seriously we take the issue.

That isn't to say that there isn't more we can do on our own. After the police leave the meeting, we'll have time to discuss crime as a community and explore various solutions—making it even more important that you attend.

Let's put it this way: I'd love to see the Rec Center filled to capacity.

Meanwhile, please keep on the lookout for suspicious persons or activity. If you're home during the day, the police suggest taking a look out the window or up and down the street periodically. If you're up in the middle of the night, peek out at the street outside and see if you see anyone testing car doors or rifling through cars. If you see something suspicious, call the police right away. We recently did, and they responded right away. They did not act as if we were a nuisance; they appreciated the call.

Most of all, make sure to lock your cars and try not to leave valuables (including GPS systems) inside. Secure your house with adequate lighting, keep the bushes trimmed to deny burglars hiding places, and make sure your locks are up to date. Explore the possibility of a home security system if that makes sense.

I hate to sound like a broken record, but I feel most of this bears repeating until we can reduce the level of crime. As the police are quick to point out, we still live in a relatively safe neighborhood. But there are too many reports of vehicle break-ins and other disturbing activity on the listserv every month—and in conversations between neighbors. Do what you can. And please join us at the Rec Center on Monday, October 20th at 7:30 pm.

• Participate and help organize a crime summit in Silver Spring led by Prezco (Presidents' Council of Silver Spring Civic Associations) in conjunction with the new Police 3rd District Adon at night.

- Ensure enough police resources, and review resource allocation across districts.
- Examine the use of community patrols.
- Increase communication from the police as to arrests, disposition of persons arrested, investigations, and use of patrols.

• Strengthen neighborhood watch, e.g., more meetings, training, additional block captains, ensure expansion of activities, more monitoring and reporting, provide more resources, etc.

• Have police conduct more home safety inspections. Please let us know your thoughts, comments and suggestions on these strategies.



Here is a copy of the letter we sent to the County Council and Executive on April 17, 2008.

To: Michael Knapp, President Montgomery County Council Dear Mr. Knapp:

The Indian Spring Citizens Association consists of 800 homes. This letter is to inform you of our Association's views on the Purple Line.

Recently, our association took a vote on the purple line. The vote was 70 in favor and 3 opposed to the following resolution which states: ISCA supports the building of the purple line from New Carrolton to Bethesda. We prefer the light rail option over the bus rapid transit option as it provides better travel times and ridership projections. We favor the purple line as the first major step forward toward developing transit solutions to our transportation needs in preference to highway solutions and we continue to oppose Beltway widening.

Our reasons for supporting the purple line are that we believe transit is a much more cost-effective way to address our transportation needs compared to highway solutions with a far better impact on the environment. With the rate of growth in this county, transit solutions are essential to address these needs. We believe the purple line is the first step in a series of transit related solutions to transportation needs. In addition to a comprehensive set of light rail lines, we also believe that our bus system needs many improvements.

As indicated in our resolution, we support light rail for the purple line over bus rapid transit. We support this position because the Maryland Transit Administration studies show that light rail has better ridership figures and better travel times compared to bus rapid transit. We believe the additional cost of light rail over bus rapid transit is worth it.

In contrast, we oppose Beltway widening as it will:

 Have a negative impact on our neighborhood and other neighborhoods adjacent to the Beltway as dozens of homes will be taken. Residents who do not lose their homes will suffer even more due to the increased noise and air pollution
 Severely damage the environment and increase noise pollution for all

• Result in more congestion on major secondary roads, such as Georgia Ave.

• Have a negative impact on parks, such as Rock Creek Park

For all these reasons, we strongly support a light rail Purple Line and are pleased to see the support of the County Council to date.

"Drive Safe, Walk Safe" Set for October 8 by Jennifer Chambers

The President's Council of Silver Spring (Prezco) has organized a pedestrian safety campaign to educate and encourage motorists and pedestrians to "Drive Safe" and "Walk Safe." This campaign is scheduled for Wednesday October 8, to coincide with National Walk to School Day. During the morning of October 8th, twelve civic associations involved in Prezco will educate motorists and walking children and adults in their neighborhood on how to drive and walk cautiously and safely at dangerous intersections and streets. Education will include: "Drive Safe, Walk Safe" vard signs; articles in neighborhood newsletters, listserves, and websites; published neighborhood school bus stop times and locations; hand-made signs and citizen presence at dangerous intersections and streets; letters to organizations or businesses asking their members and patrons to drive and walk safely in their neighborhoods; and cooperation with each neighborhood's elementary school to help organize Walk to School Day events. For example, parents in the Indian Spring neighborhood will organize and participate in the "Walking School Bus" to Highland View Elementary School during the morning of October 8th. Metro to the Polls

Prezco is a coalition of twelve civic associations in Silver Spring that advocate for the concerns and needs of their residents. In early 2007, Prezco made it a priority to advocate for increased pedestrian safety on the streets in Silver Spring. Each civic association contributed to a list of unfriendly pedestrian roads, intersections, and situations in their neighborhoods. Eighty pedestrian safety problems were identified and included in a chart that organized the roads by their primary, secondary, and jurisdictional status; roads were also coded as hot-button issues or as problems that could be easily fixed, such as restriping a crosswalk. In September 2007, Prezco submitted this chart to the Montgomery County Executive, County Council, and the Department of Public Works and Transportation (DPWT). All three were very receptive and responsive to Prezco's advocacy on this issue. In particular, DPWT has worked well with Prezco to alleviate the unfriendly pedestrian situations in our neighborhoods. Since June of this year, eighty percent of the pedestrian safety problems identified by Prezco have either been resolved or the projects have been completed. When County Executive Ike Leggett and Councilmember Valerie Ervin announced Montgomery County's Pedestrian Safety Initiative last December, they credited Prezco's plan as its inspiration.

Tips on How to "Drive Safe, Walk Safe" By Eileen Fisher

October 8th is National Walk to School Day, which provides a great opportunity to mention some safety tips that will make roadways safer for all users, as well as some of the many benefits of walking.

First, some tips for drivers. There are morning and afternoon school bus stops in our neighborhood, particularly along Indian Spring Drive, Caroline Avenue and Worth Avenue. Please watch carefully for children standing at the bus stops, as well as those who are racing to catch the bus.,

The speed limit in our neighborhood is 25 miles per hour, but it is always good to go below that. Here's why: a pedestrian's chance of death if hit by a motor vehicle traveling at 20 miles per hour is 15 percent. This rises to 45 percent when the vehicle is traveling 30 miles per hour, and 85 percent when the vehicle is traveling 40 miles per hour. (source: National Highway Traffic Safety Administration).

Our neighborhood streets are often crowded by moving cars, parked cars, bicyclists and pedestrians of all ages. Remember to scan the road and sides of the road for pedestrians, and look in all directions before making a turn. Always yield to pedestrians at crosswalks, both marked and unmarked, and do not block or park in crosswalks. Finally, come to a complete stop at stop signs, and be prepared to stop for pedestrians in the neighborhood and near schools.

Pedestrians also need to do their part. Make yourself visible to drivers by wearing bright, light, or reflective clothing. Reflective materials can make pedestrians visible from up to 500 feet away. Carry a flashlight at night and don't wear headphones. Make sure you're visible to drivers and not obstructed by fences, trees or hedges.

Always walk on the sidewalk. If there is no sidewalk, walk facing traffic (but cycle with traffic). Be on the lookout for cars reversing in parking lots and near on-street parking areas. Cross the street at marked crosswalks or intersections whenever possible. Obey traffic signals such as 'walk' and 'don't walk' signals, but also look left, right, behind you and left again before crossing a street or stepping into traffic. Watch for turning vehicles—make sure the driver sees you and will stop for you.

Here are some great reasons to walk:

• It's cheaper to walk: there are many costs associated with driving, including cost of the vehicle, insurance, inspection, registration, parking fees, maintenance, and (forefront in many people's minds) gas.

• Walking is good for the environment: unlike driving, walking does not contribute to air, noise, or water pollution;

• Walking can reduce the demand for existing and new roadways: many streets carry more traffic than they were designed to handle, resulting in gridlock, wasted time and energy, and pollution. Providing opportunities to walk can help more people out of frustrating traffic congestion;

• Walking can improve people's health: regular walking can aid in weight loss; lower blood pressure; improve cholesterol, blood sugar, and immune system function; prevent bone loss; reduce risk of coronary heart disease, stroke, and other chronic disease; and improve mood and mental performance;

• Walking improves the quality of our lives: walking provides personal benefits such as a sense of independence and freedom of choice, as well as social benefits such as opportunities to interact with others, build community closeness, and keep more eyes on the street, perhaps making the neighborhood safer;
