PRESIDENT'S MESSAGE

APPY FALL EVERYONE!

And with the turn of the season comes Redskins football, which may explain the lower turnout for our September ISCA meeting. Despite the smaller number of participants, we did have a lively, very informative discussion. The focus of the meeting

was on the proposed curfew bill. But our guest speakers covered a full range of issues related to teens and crime in our area.

Lt. Robert Carter proposed one way of curbing daytime crime by addressing truancy, and creating greater security in business areas by strengthening loitering laws, in addition to the proposed curfew. Mo. Co. Parks Dept.

Director Mary Bradford talked about the challenges of creating programs and venues for teens to gather safely. And County Councilmember George Leventhal gave us a summary of the curfew bill, and talked about plans for additional County Council work sessions and a youth town hall meeting, which may lead to possible revisions. The bill will likely not be voted on until mid-November. He also stressed that downtown Silver Spring is doing well. Lt. Carter added that the opening of the Fillmore went "swimmingly" and he expects it to be an excellent new amenity to our area.

In our conversation regarding downtown Silver Spring, Victor Salazar, operations manager for the Silver Spring Urban District, apprised us of the services of "the Red Shirts" who help keep DTSS safe and friendly for all. You may want to save their hotline number (240-876-2911) in your cell. From 6 a.m. until midnight they are available to escort you to your vehicle, assist with automobile lock-outs and jump starts, answer questions and provide directions.

They provide wonderful care for DTSS by maintaining the streetscapes and public amenities, and serving as extra eyes and ears for the police force.

Regarding police presence, we asked Lt. Carter about the recent rash of thefts from vehicles in Indian Spring. He said we were not alone in being hard hit, and they have caught a few of the perpetrators. His supervisor is aware of the wave and has assigned extra night patrolling to our area. He reminded attendees to never leave anything of value in their cars and to lock doors. Also, he urged everyone to report any theft or attempted theft that occurs. He stressed that if you don't report it, it's as if it never happened. One easy way to report is to simply go to www. montgomerycountymd.gov and click on the Department of Police page.

Lastly, Del. Tom Hucker joined us to provide a brief overview of the Maryland House of Delegates' upcoming special session, and answer questions. For more detailed information about this and other topics of our meeting, please see the minutes later in the newsletter courtesy of ISCA Secretary Suresh Srinivasan.

With temperatures dropping, the cool air makes for lovely walks around the neighborhood. But the shorter days also mean it gets dark earlier. Please keep an eye out in the evenings for pedestrians when you're driving, and be very careful—especially around the kids' bus stops—in the early mornings as well. Pedestrians, please be aware you're less visible these times of day and be cautious of vehicles that may be passing by. ISCA General Meeting, September 26, 2011

HE MAIN AGENDA for the meeting was the proposed teen curfew for Montgomery County. To discuss the issue were: Lt. Bob Carter of the Montgomery County Police Department, Montgomery County Council Member George Leventhal, Richard Romer from Council president Valerie Ervin's office, Victor Salazar, the operations manager for the Silver Spring Urban District. Delegate Tom Hucker representing our district 20 in the Maryland House of Delegates, and ISCA residents Mary Bradford of the County Dept. of Parks, and Tony Hausner representing the Safe Silver Spring initiative and ISCA residents.

Unfortunately attendance was sparse—maybe the Monday night Redskins game had something to do with it. But the discussion was very informative and the speakers engaging. The meeting started with a discussion of the related issue of truancy. Lt. Carter indicated that 2% to 3% of public school students are habitually truant, defined as 20 or more unexplained absences. That is between 3 and 4 thousand students. Perhaps the police working in concert with other parties such as parents, school officials, teen court judges, etc could identify these cases and intervene early. Tony mentioned that many truants become gang members and that for gangs, there has been an increase in membership by 12% since 2009 and a 25% increase for serious crimes. Currently, the police really have no real tools to deal with this issue. Mr. Salazar made the point that gang

members tend to be truants but not all truants are members of gangs. Of course the ISCA survey on this issue had ~40 respondents of which over 70% agreed with the proposed legislation.

ISCA president Jill Ortman-Fouse said that crime is the biggest concern in the neighborhood. Most crimes occur after 11pm and involve theft from vehicle (TFV).

Mr. Leventhal said he is neutral on the issue of the curfew and has not yet made up his mind on it. He succinctly summarized the proposed legislation (which is not cast in stone) and which will be voted on November 1st. The proposal as it stands will affect individuals under 18 years of age, after 11pm Monday through Thursday and Sunday, and after midnight Friday and Saturday. There are exceptions for kids returning home from work, sporting or entertainment events, or engaged in religious, school or any first amendment activity (for example protesting this very law after midnight!) or is accompanied by a parent. Mr. Leventhal admitted being troubled by some of the dialog around this issue that might create the impression in the public mind that downtown Silver Spring is not a safe place to be. In fact there was general consensus around the room that Silver Spring is safe with many dining and entertainment opportunities.

The newly opened Fillmore has been a very positive experience. The concern was traffic and pedestrian safety and even on those areas it has been a huge success. The 2000 people exiting after the event do so in an orderly and safe manner.

But as Lt Carter mentioned, there is change in the crowd after 11 pm. The families have left and that it is mostly made up of young couples and unsupervised teens. There are groups coming off the metro taunting and flirting with girls. Trouble can start quickly when they bump into someone they don't like. In the district (which has a 11pm curfew), the teens melt away after 11pm leaving behind mostly older diners. Tony also mentioned that the curfew is not a panacea and more will need to be done to address juvenile crime. Ms. Bradford mentioned that the skate park in Woodside park is going well with well-lit areas and active patrols.

Remembering Robert Myers

N SEPTEMBER 26, 2011, there was a street naming ceremony in Baltimore MD. Mr. Myers was a resident of Indian Spring for many years. Here is more information posted last year by the Social Security Administration at the time of his death.


Robert J. Myers died on February 13, 2010, at age 97. He devoted his life to Social Security and made an indelible mark on the program.

After receiving a Masters Degree in Actuarial Science from the University of Iowa in 1934, Robert Myers began his career as a junior actuary with the Committee on Economic Security—which he described as being a matter of great good luck—simply being in the right place at the right time. In this position, he helped shape the Social Security program that was enacted into legislation one year later in 1935. One of his tasks was to figure out a fundamental detail of the program—the age at which people should become eligible to stop working and start drawing benefits, while still allowing the program to pay for itself. The result was the age-65 retirement age.

Myers was among the early employees of the Social Security Board (the precursor to the Social Security Administration), becoming a permanent Social Security actuary

in the summer of 1936. By 1947, he became the Chief Actuary of Social Security. He was the longest-serving Chief Actuary, serving for 23 years from 1947 to 1970. During this period, he played an instrumental role in several pieces of major legislation, including the expansion of coverage in 1950, enactment of disability insurance in 1956, and enactment of Medicare in 1965. Also, as Chief Actuary, he introduced the 75-year long-range projection of the actuarial balance of the trust fund. This projection was not widely used in other countries, but is a hallmark of our annual Trustees Reports.

To assist with efforts to deal with the financing crisis, Myers returned to the Social Security Administration in 1981 for about a year as the Deputy Commissioner for Programs. Long after leaving the Social Security Administration, he continued his




"I believe that there is an appropriate role for both private pension plans and Social Security ... each system should be of about equal importance." involvement in the Social Security program. He served on numerous commissions and Congressional panels. Notably, in 1983, he was named the executive director of the National Commission on Social Security Reform (also known as the Greenspan Commission), which succeeded in developing a consensus recommendation that became the 1983 Amendments to the Social Security Act. He was a prolific writer, with more than 900 articles and several books to his name and held a record for having testified before Congress 175 times. Myers was also a leader in the broader fields of social insurance and actuarial science. He was a founding member of the National Academy of Social Insurance, serving on its Board of Directors from 1986-87. In 1994, the American Academy of Actuaries created the Robert J. Myers Public Service Award to honor actuaries who have made an exceptional contribution to the common good. He also served as the president of both the Society of

Actuaries and the American Academy of Actuaries.

Myers' work, although esoteric, touched the lives of millions of Americans. Stephen Goss, the Chief Actuary at the Social Security Administration since 2001, says "Myers was singularly responsible for the strength and principles now cherished and guarded at the office he formed." The former Senator Daniel Robert J. Myers, SSA History Archives. **

Mr. Salazar, of the Silver Spring Urban District helps provide special services in the Central Business District with the so-called Red Shirts—teams that help keep the downtown area safe and clean and provide extra sets of eyes and ears. There are 30 members who patrol 18 hours a day (in shifts) and clean up graffiti and patrol public areas, provides escorts, battery assistance, etc. Their goal is to make Silver Spring look like Disney World! They have a hotline number till midnight if you are every in need: 240-876-2911. More information at: http://www.montgomerycountymd.gov/Content/RSC/SilSprng/redshirts.asp.

Lt. Carter mentioned that there are two dedicated MCPD bike teams assigned to downtown Silver Spring.

Tony Hausner, chair of Safe Silver Spring noted that while adult crime is down, juvenile crime is up 70% in Silver Spring. A curfew could provide an additional tool to law enforcement to keep youth off the streets and out of harms way. A metropolitan-wide regional approach would be needed to keep kids engaged.

A reminder to sign up for ISCA membership if you haven't already done so. The November meeting will focus on traffic safety issues. The fall festival is scheduled for October 23rd. **






